Explanatory Notes:

- *1. All applicants must agree to abide by the Membership Rules of the Hong Kong Internet Service Providers Association (HKISPA). Membership of the Hong Kong Internet Service Providers Association is open to corporations and individuals who strive to advance the Internet industry in Hong Kong and promote the adoption of new Internet technologies. There are three types of memberships.

- *2. An annual subscription fee of **HK\$1,500 applies** for applicants who want to join HKISPA
